ADMISSION AND SEEDING	According to 2022 CEV U18 Country Ranking and the CEV Beach Volleyball Guidelines.
RIGHT OF PARTICIPATION & REGISTRATION	<p>An athlete wishing to take part in a CEV sanctioned competition must possess the nationality of the country he/she intends to represent and must fully comply with the requirements laid down by the FIVB Sports Regulations. In addition, each athlete needs to have the following documentation completed/updated on his/her VIS profile:</p> <ul style="list-style-type: none"> upload the BV-01 Athlete's Commitment and BVB/10 Annual Health Certificate forms to his/her VIS profile have completed the FIVB Anti-Doping education programme "Play Clean", and the Prevention of Competition Manipulation course that can be found here <p>Athletes' wishing to participate shall be aged under 18 years on 31st of December of the year during which the respective Championships is held (for this season Born on 1st of January, 2005 or after).</p>
UNIFORMS	<p>The Organiser will not provide uniforms to the participating teams</p> <p>As a result the participating National Federations shall provide their players with minimum 2 sets of uniforms in different colours according to the layout specified in CEV U18 BV European Championships Official Communications document and may exploit them commercially (excluding the following product categories: alcohol (spirits), tobacco & pornography).</p> <p>Participating National Federations are responsible to bring their own shorts/bikini bottoms as per the provisions of the CEV Beach Volleyball Regulations and the Official Communication. Players may use gear and accessories as defined in the CEV Beach Volleyball Guidelines.</p> <p>To their coaches entering the Field of Play, as per the CEV Coaching Regulations document, available on the event's page of the CEV website.</p>

CONTRIBUTION FEE	<p>As per the CEV U18 BV European Championships Official Communications document, a contribution fee is a fee paid for each Main Draw or Qualification team member to the organiser in order to contribute to its accommodation and local transportation.</p> <p>National Federation shall bear all costs related to all accredited team members. For the CEV Age Group Beach Volleyball European Championships this amount equals EUR 70 (seventy Euros) per day for two players and one team official (coach, head of delegation, doctor, physiotherapist). <p>BOARD AND LODGING</p>	<p>The Local Organiser will provide the 2 players and 1 delegation member per team with hotel accommodation (twin rooms) and meals, for teams participating in the Qualification Tournament from the afternoon of 30th August (dinner) until 1st of September (breakfast) and for teams participating in the Main Draw from the afternoon of 31st August (dinner) until 5th September (breakfast).</p> <p><u>Women's teams hotel:</u> Loutraki SPORTCAMP Rooms are all recently renovated with private bathroom and kitchen, free use of camp facilities: Gym, Swimming Pool and additional sports facilities.</p> <p><u>Men's teams hotel:</u> Paolo Hotel*** or Bakos Hotel*** in Loutraki</p> <p>Breakfast will be served in the respective hotel, while lunch and dinners will be served in the Loutraki SPORTCAMP dining area.</p> <p>Team officials (coach, head of delegation, doctor, physiotherapist) will be accommodated in twin rooms (standard policy is in the same hotel with the team although this may not always be possible as different hotels are used for men and women teams). Single room supplement is an extra €40 per day.</p> <p>For additional delegation members or extra days of stay please contact organiser to confirm availability and arrangements as per the following conditions and options:</p> <p>The rates for extra delegation members or extra days of stay will include all services as per the official staying period (board and lodging, local transportation -airport – hotel – venue, access to Loutraki SPORTCAMP and use of training courts). The rate that applies is €70 per person/day in twin/double rooms. A discount can be offered in the SPORTCAMP for triple or quad rooms.</p> <p>The respective National Federation shall bear the board & lodging cost for all accredited team members, regardless if they wish not to take the offer provided by the organiser.</p> <p>For all requests and arrangements please contact the organiser at: events@sport-travel.gr with cc to beach@volleyball.gr</p>
<p>ACCREDITATION</p>	<p>Organisers will provide all organising committee members, CEV officials, referees, players, team official (accredited coach, head of delegation, doctor, physiotherapist), technical staff with official accreditation cards and will ensure that only those people will have access the designated venue areas.</p> <p>An individual is considered a team official when his/her accreditation request is duly submitted, fulfill all the requirements and hold an accreditation for a competition. National Federation may request a maximum number of 2 (two) accreditation for team officials per team, however the respective organiser may agree on a higher number. For the CEV U18 Beach Volleyball European Championships 2022 the organiser can provide up to 4 accreditations per team.</p> <p>The accreditation for medical staff (doctor, physiotherapist) as per the process defined in the respective BV-06 form "Accreditation of Medical Staff (Please scroll down until section "Beach Volleyball Forms/National Federations").</p>
